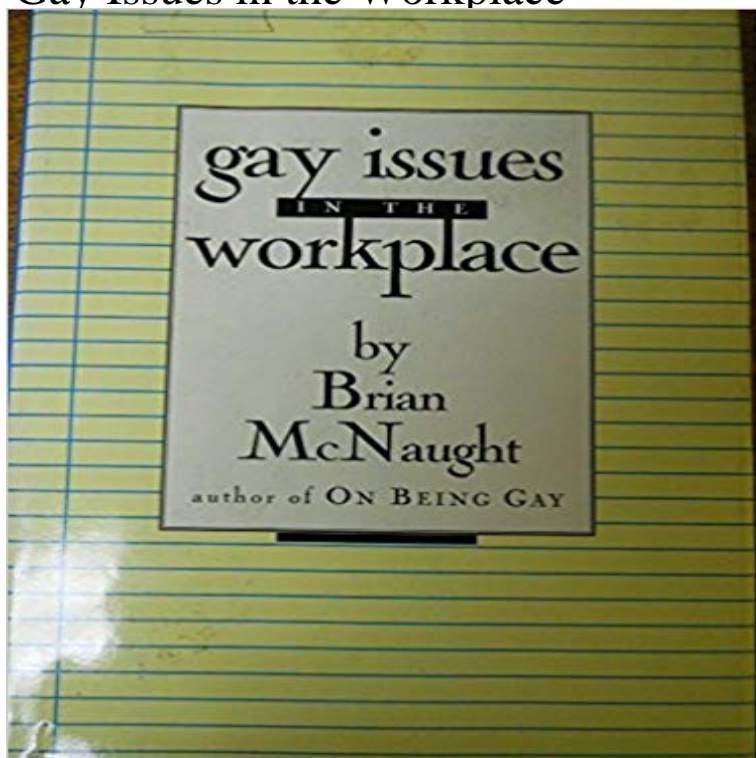


Gay Issues in the Workplace
