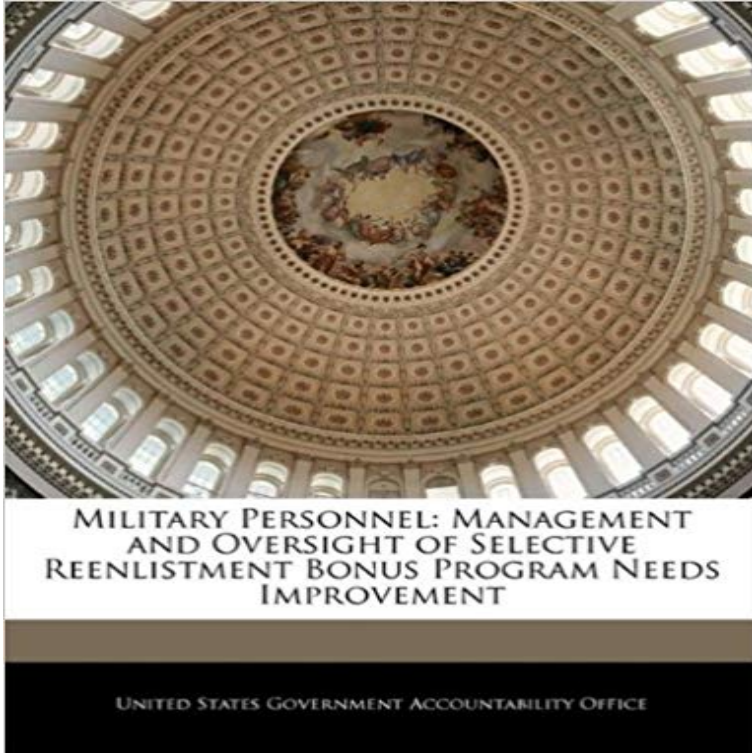


Military Personnel: Management and Oversight of Selective Reenlistment Bonus Program Needs Improvement
